- The weigh station is at Indian Peaks Marina, 6862 US-34, Granby, CO 80446
- The contest begins at 6:40am each day. Weigh station hours: Fri & Sat: 9am - 4:30pm, Sun: 9am - 2pm
- The Leaderboard will be updated on our 3 LAKES ICE FISHING CONTEST FACEBOOK PAGE throughout the contest
- You must be IN LINE at the weigh station at 4:30pm Fri. & Sat., and 2pm Sun. TO BE ELIGIBLE FOR CASH PRIZES
- All CASH winners must be present at 5:30pm on Fri. & Sat., and 3pm Sun. at the Granby Community Center, 193 3rd Street in Granby to receive their award. If not present award will go to the next biggest fish.
- Because of changes in state regulations, one "prize ticket" (not raffle ticket) is included with each paid adult entry and will be entered in a drawing to be held at the Saturday Award Ceremony, *Must be present to win.* Additional tickets can no longer be purchased. Participants will be entered in the prize drawing only once. Door prizes awarded daily.

**Brown Trout & Rainbow Trout:** 1st-\$600, 2nd-\$300, 3rd-\$150, 4th-\$125, 5th-\$100, 6th-\$75, 7th-\$50, 8th-\$50

**Grand Slam:** Catch one qualifying fish in each of the following species: Mackinaw (under 19") Rainbow Trout, Brown Trout, Kokanee Salmon: 1st-\$750, 2nd-\$350, 3rd-\$175, 4th-\$150, 5th-\$100, 6th-\$75, 7th-\$50, 8th-\$50

**Big Fish Catch & Release Drawing Each Day:** For Mackinaw over 32" that have been caught, photographed **AND** released: **TROPHY ONLY, PLEASE HANDLE MACKINAW OVER 19" CAREFULLY AND RELEASE QUICKLY \*SEE REGULATIONS\***

**TAGGED FISH:** Fish caught by Paid Youth or Adult, **HOT PINK TAG on dorsal fin marked 3 Lakes Tourney, numbers 41-60 only are eligible for \$1000 per fish.**
